Compac Fixed Assets Register

The control of assets and calculation of depreciation can become increasingly complicated unless the accountant has a suitable supply of information.

The Compac Fixed Assets Register stores details of individual assets. It also calculates, records, and accumulates depreciation for one or more accounting periods. Information is summarised for different user-defined classes of asset so that figures are ready for direct transfer or agreement with those of any accounting system.

The user may change any incorrect entries within the current or previous few accounting periods.

Each new asset is inserted into one of the asset classes. The details stored include the following:

Depreciation types are reducing balance and straight-line. Alternatively, zero or a separately calculated figure of depreciation may be entered instead. Automatic depreciation uses a standard accounting period length applicable to each accounting period but for any particular asset there may instead be a special period length. Calculated depreciation may be rounded to the nearest penny or pound or arranged so that the net book value carried forward rounds to the nearest pound.

All information may be either viewed on screen or printed out. Journal transfers relating to depreciation and disposals may be posted as a Journal Schedule directly to the Compac Main Accounts.

100 asset classes may be employed but a typical number is less than 10. The system is designed to expand with the number of individual assets. A few thousand is not unreasonable.
